RESOLUTION No. 02-20**

RESOLUTION DECLARING THAT IT IS DESIRABLE FOR THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS OF THE COUNTY OF CHESTER FOR THE CHESTER COUNTY HEALTH AND EDUCATION FACILITIES AUTHORITY TO UNDERTAKE A PROJECT INVOLVING THE ISSUANCE OF REVENUE BONDS IN AN AMOUNT NOT TO EXCEED \$215,000,000; APPROVING THE PROJECT UNDER SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED; AND REPEALING ALL PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS

The following recitals are a part of this Resolution.

A. Main Line Health System (the “Corporation”) has requested the Chester County Health and Education Facilities Authority (the “Authority”) to approve a financing which will include, pursuant to the provisions of the Municipality Authorities Act, Act 22 of 2001, 53 Pa.C.S. §5601 et seq., as amended (the “Authorities Act”), the issuance of the Authority’s Health System Revenue Bonds (Main Line Health System), Series 2020, in one or more series, in an aggregate principal amount not to exceed \$215,000,000 (collectively, the “Bonds”).

B. The Corporation has asked the Authority to issue the Bonds to finance, together with other available funds of the Corporation, the costs of a project (the “Project”) consisting generally of (i) constructing, renovating and equipping health care and related facilities of Riddle Memorial Hospital at 168 West Baltimore Pike, Media, Delaware County, including the construction of an approximately 229,000 square foot patient care Pavilion on the Riddle Hospital campus, as well as the renovation of 62,000 square feet of existing hospital space; (ii) miscellaneous budgeted capital improvements of MLHS and its affiliates including, without limitation, constructing, acquiring, renovating and equipping health care and related facilities at (A) Paoli Hospital at 255 West Lancaster Avenue, Paoli, Chester County; (B) Bryn Mawr Hospital at 130 South Bryn Mawr Avenue, Bryn Mawr, Montgomery County; (C) Lankenau Medical Center at 100 Lancaster Avenue, Wynnewood, Montgomery County; (D) Bryn Mawr Rehab at 414 Paoli Pike, Malvern, Chester County; Riddle Memorial Hospital at the above address; and Mirmont Alcohol Treatment Center at 100 Yearsley Mill Road, Media, Delaware County; (iii) payment of capitalized interest; and (iv) the payment of the costs of issuance of the Bonds.

C. The Authorities Act authorizes the financing of the Project for the Corporation, and with respect to the Project and certain other projects, requires that “each municipality organizing an Authority ... shall declare by resolution or ordinance that it is desirable for the health, safety and welfare of the people in the area served by such facilities to have such facilities ... financed through [the] authority.” 53 Pa.C.S. § 5607(b)(2)(iv).

D. Pursuant to the Authorities Act, the Corporation and the Authority have requested the Board of County Commissioners of the County of Chester (the “Board of County Commissioners”) to declare, by this Resolution that the Project is desirable for the health, safety and welfare of the people in the area served by the Corporation.

E. Section 147(f) of the Internal Revenue Code of 1986, as amended, 26 U.S.C. §147(f) (the “Code”), requires that the applicable elected representatives of the governmental unit on behalf of which bonds are issued and of each governmental unit having jurisdiction over the area in which any facility, is located, approve bonds after a public hearing in order for a private activity bond to be a qualified bond under the Code.

F. The Board of County Commissioners constitutes the appropriate elected representatives for the purposes of giving Section 147(f) approvals.

G. On January 14, 2020, the Authority held a hearing in compliance with Section 147(f) pursuant to public notice.

H. The Authority approved the Project and the Bonds on January 14, 2020.

I. Pursuant to Section 147(f) of the Code, the Corporation and the Authority have requested the Board of County Commissioners to approve the issuance of the Bonds for the purposes of Section 147(f) of the Code.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of the County of Chester as follows:

SECTION 1. It is hereby determined and declared pursuant to the Authorities Act that it is desirable for the health, safety and welfare of the people in the area served by the Corporation for the Authority to undertake the financing of the Project through the issuance of the Bonds in an aggregate principal amount not to exceed \$215,000,000.

SECTION 2. The issuance of the Bonds and the financing of the Project are hereby approved.

SECTION 3. The foregoing determination, declaration and approval are for the purposes of the applicable provisions of the Authorities Act and the Code and do not constitute approval for any permit, license or zoning required for the construction or occupancy of any facilities to be financed or refinanced as part of the Project.

SECTION 4. The adoption of this Resolution is not a pledge of any revenues or security by the County of Chester. Neither the credit nor the taxing power of the County of Chester, the Commonwealth of Pennsylvania, or any political subdivision, agency or instrumentality thereof is pledged for payment of the Bonds.

SECTION 5. All actions of this Board of County Commissioners taken in conformity with the intents and purposes of this Resolution are ratified, confirmed and approved in all respects.

SECTION 6. This Resolution shall take effect immediately. All prior ordinances or resolutions or portions thereof inconsistent herewith are hereby repealed.

**RESOLUTION OF THE CHESTER COUNTY COMMISSIONERS AUTHORIZING
SIGNATURE AUTHORITY AND APPROVING REIMBURSEMENT AGREEMENT**

WHEREAS, The County entered into an Intergovernmental Agreement (County Contract ID# 8601) with PennDOT on October 11, 2006 to have electronic access to PennDOT's Engineering and Construction Management System ("ECMS") which was later expanded to include the Reimbursement Agreement System ("RAS"); and

WHEREAS, PennDOT utilizes ECMS for all construction projects to advertise for bids, accept bids, award bids and sign construction agreements, and execute all pertinent documents between the parties therein; and

WHEREAS, the County of Chester ("County") and the Pennsylvania Department of Transportation (PennDOT) are desirous of entering into an Agreement, whereby County and PennDOT agree to participate in a Federal-Aid Highway Program/Project to replace County Bridge No. 244, Hadfield Road over Beaver Creek located in East Brandywine Township, Chester County, PA; and

WHEREAS, PennDOT and the County are both desirous of entering into Reimbursement Agreement No. R20060001 to include costs for replacement of Bridge #244 as shown in attached Exhibit "A" and made part of this Agreement; and

NOW, THEREFORE, BE IT RESOLVED, by the authority of the Board of Commissioners of Chester County, and after review by the County Solicitor, that the Director of the Department of Facilities be authorized and directed to singularly execute the necessary Reimbursement Agreement in RAS on behalf of the entirety of the Board of Commissioners, and in doing so, agree to be legally bound to the terms, conditions and provisions set forth therein and the Chief Clerk be authorized and directed to attest to the same on behalf of the Board of County Commissioners of Chester County,

FURTHER, that the Commissioners of the County of Chester hereby authorize the Director of the Department of Facilities upon consultation with the County Solicitor, to take any and all necessary steps to execute all documents required under the PennDOT Reimbursement Agreement System (RAS), and to perform all bridge repairs and inspections as specified in the Agreement in an amount not to exceed \$946,225.65 and further comply with the appropriate submissions/requirements for reimbursement from PennDOT for the maximum allowable amount under the contract.
